Supplement to the Registration Document

"Save as disclosed in (i) the section entitled "JPMorgan Chase & Co. – Litigation" on pages 64 to 68 of this Registration Document and (ii) the section entitled "Note 24 – Litigation" on pages 156 to 159 of the Quarterly Report on Form 10-Q of JPMorgan Chase & Co. for the quarter ended 31 March 2021, containing the unaudited financial statements of JPMorgan Chase & Co. for the quarter ended 31 March 2021, as filed with the United States Securities and Exchange Commission on 4 May 2021 and incorporated by reference into this Registration Document, JPMorgan Chase & Co. is not and has not been involved in any governmental, legal or arbitration proceedings relating to claims or amounts that are material during the 12-month period ending on the date of the most recent supplement to this Registration Document which may have, or have had in the recent past, significant effects on the financial position or profitability of JPMorgan Chase & Co. nor, so far as JPMorgan Chase & Co. is aware, are any such governmental, legal or arbitration proceedings pending or threatened."
